Delrice Adams, Executive Director, Illinois Criminal Justice Information Authority (ICJIA)



Delrice Adams is a justice warrior with over 25 years of directing social service and public health reform efforts. On January 4, 2020, Illinois Governor J.B. Pritzker appointed Delrice to lead the Illinois Criminal Justice Information Authority (ICJIA). ICJIA spearheads and informs on public safety policies, research, and best practices. In this role, Executive Director Adams leverages her expertise in criminal justice, violence prevention, and racial equity to support the agency's work. Her expertise informs and enhances public safety priorities, equity grant administration, and evidence-based solutions to violence prevention.

Executive Director Adams institutes a transparent and straightforward approach to the work. Equity, fairness, and opportunity are the priorities of every grant program and policy administered by ICJIA.

A visionary leader trained in trauma-informed approaches, Executive Director Adams co-chairs a first-of-its-kind cross-governmental violence prevention advisory group with county and city officials. She also chairs or administers various state boards and commissions, such as the Ad Hoc Victim Service and Prevention committee, Domestic Violence Pretrial Working Group, and Violent Crime Reduction Taskforce. Nationally, she is the Chair of the National Criminal Justice Association's Board of Directors Equity in Criminal Justice Funding and Budget Committee.

Previously, Executive Director Adams held progressive leadership roles at the Cook County Justice Advisory Council and the City of Chicago's Department of Public Health Office of Violence Prevention and Behavioral Health. In these roles, she was responsible for the restorative justice and violence prevention initiatives. A trained peace circle keeper, Executive Director Adams' successes are grounded in her love for and strong ties with the community.

Executive Director Adams received a bachelor's degree in psychology from the University of California at Berkeley and holds a master's degree in social service administration from the University of Chicago. In July 2022, Executive Director Adams was selected into the highly competitive National Criminal Justice Association Leadership Academy for Executives where she represented the great state of Illinois.

Dr. April Bernard, Ph.D., Chair and Associate Professor of Criminal Justice, Chicago State University

Dr. April Bernard is Chair and Associate Professor of Criminal Justice at Chicago State University. Dr. Bernard received her doctorate in Human Development and Social Policy at Northwestern University's School of Education

Prior to joining Chicago State University in 2012, she worked as a consultant with the United Nations Development Program Caribbean Human Development Report on Crime and Citizen Security and served as a deputy dean of the Faculty of Social Sciences at the University of the West Indies in Barbados where she also lectured in Sociology. Her articles have appeared in Feminist Criminology, the Journal of the Institute of Justice & International Studies, and The Journal of Pan African Studies among others. Her work was also featured in the Routledge Major Works: Critical Criminology, Critical Concepts in Criminology Series, Volume IV: Critical Interventions: Engaging Social Justice (2014). Dr. Bernard is the author of the book "Transforming Justice, Transforming Lives: Women's

Pathways to Desistance from Crime" (2015).

Scott A. Block, Statewide Behavioral Health Administrator, Administrative Offices of the Illinois Courts (AOIC)



Scott Block is the AOIC's Statewide Behavioral Health Administrator, and in that role, serves as the Illinois Judicial Branch's dedicated voice and resource, committed to furthering local, state, and national behavioral health and justice initiatives. In this capacity, he is the project director for the Illinois Mental Health Task Force, provides strategic and technical consultation for Illinois Courts, and acts as liaison behavioral health and justice affiliates and organizations.

Throughout his 20+ year career in the behavioral health field, Scott has held leadership roles in the public and private sectors, and he has been recognized as subject matter expert and innovator with multiple honors and awards. He has

served on numerous governmental and not-for-profit boards, committees, and work groups, helping to shape policies and inform best practices. He is also educating the future workforce as an Adjunct Professor at Aurora University, teaching Graduate Addictions courses.

Scott earned a master's degree in Counseling, is a Licensed Clinical Professional Counselor, Certified Alcohol and Other Drug Counselor, Certified Criminal Justice Addictions Professional, and a National Center for State Court's Certified Court Manager.

Deanie Brown is a Springfield attorney and the Chief Diversity and Inclusion Officer for the Administrative Office of the Illinois Courts and the Judicial Branch and court services.

She has been associate chancellor, chief of staff, and director of HR and internal relations at universities in Illinois, California, and New Orleans, and serves on several boards supporting equity, education, the community, and the arts. Her expertise includes nondiscrimination and human rights law, social justice advocacy, and culturally competent conflict resolution. Deanie has served attorneys throughout the state as a member of the Hearing Board for the Illinois Attorney Registration and Disciplinary Commission and has been a member of the ISBA since 2008.

Mary Ann Dyar is the Program Director for the Adult Redeploy Illinois program created by the Crime Reduction Act of 2009 (P.A. 96-0761). As Program Director, Mary Ann is responsible for coordinating the disbursement of grants to local jurisdictions to expand alternatives to incarceration; assisting with the formulation of policies and procedures for the program; monitoring and conducting technical assistance for grantees; managing communication, outreach and reporting strategies for the program; and staffing the Adult Redeploy Illinois Oversight Board.

Prior to her work at the state level, Mary Ann was Program Manager with the Justice/Violence Initiative of Chicago Metropolis 2020, a regional planning not-for-profit organization, working on policy issues related to childhood exposure to trauma and violence, juvenile justice, prisoner reentry, criminal law and sentencing reform. Pritzker to the Illinois Juvenile Justice Commission where she will serve a 3-yr term. In May 2021, Keyria also joined Lt. Governor Julianna Stratton's Advancing DJJ Transformation Committee where she and her colleagues from around the State of Illinois work to transform the state's juvenile justice system. Keyria's research interests include public administration, public policy, criminal justice issues, reentry, social justice, expungement, diversion, deflection, restorative justice, probation, and community-based program development in the United States and around the world. As a grant writer and public manager, she creates budgets for non-profits, government agencies, independent contractors, foundations, and community-based organizations. To date, she has written grants and managed more than 7.1 million dollars in various types of funds for government and community-based programming.
