Lifting the Emerging Adult Population Program (15 participant capacity)

It is the mission of the Montgomery County Lifting the Emerging Adult Population (LEAP) Program to enhance public safety and reduce recidivism by diverting persons between the ages of 18-25 and charged with a criminal offense from the criminal justice system. In doing so, the individual's quality of life may be greatly enhanced. Increased public safety will be afforded to the citizens of Montgomery County and substantial cost savings will be realized, as there will be an increase in educational, employment, financial, and daily life skills, as well as improved behavioral health for the emerging adult population.

The goals and objectives of the Montgomery County LEAP Program are to enhance public safety and improve the educational, employment, financial, daily life skills, and the behavioral health for the emerging adult population. This will be accomplished by addressing the criminogenic risk and needs, and assisting them in day to day skills through evidence based programs.

Mental Health Court (15 participant capacity)

It is the mission of the Montgomery County Mental Health Court to enhance public safety and reduce recidivism by diverting persons with a behavioral health disorder and charged with a criminal offense from the Criminal Justice system to the Montgomery County Mental Health Court for appropriate treatment and support services. In doing so, the individual's quality of life will be greatly enhanced. Increased public safety will be afforded to the citizens of Montgomery County and substantial cost savings will be realized as there will no longer be inappropriate involvement of persons with behavioral health disorders in the criminal justice system.

The goals and objectives of the Montgomery County Mental Health Court Program are to enhance public safety and improve the quality of life for the individual participants, their families and the community by reducing the likelihood that they will reoffend. This will be accomplished by addressing their criminogenic risks and needs, and assisting them to achieve and maintain recovery through the utilization of targeted mental health resources and intensive monitoring.
